Below is a brief overview of the day:

1. How to help a hedge fund to stand out from the crowd? What makes a hedge fund launch successful? Why some fail?

The first session was jointly presented by Mr. Scott Peterman (Partner of Jones Day), Ms. Dylon Tao (Prime Services Coverage and Consulting - China, Credit Suisse Investment Bank), Mr. Henry Lam (Vice President of Deutsche Bank Prime Brokerage Consulting) and Mr. Disheng Zhang (Executive Director of Morgan Stanley Prime Brokerage).

They had a discussion on the key to hedge funds' success and the reason why some hedge funds launch successfully while some failed.

2. Recent and upcoming challenges for fund managers and hedge fund managers from fund administrator, auditor and tax adviser perspectives

They discussed in depth the recent and upcoming challenges for fund managers and hedge fund managers from fund administrator, auditor and tax adviser perspectives.

3. Anti-Money Laundering and Counter Terrorist Financing Compliance Training

This session was jointly presented by Ms. Josephine Chung (Director of CompliancePlus) and Ms. Queenie Yu (Senior Consultant of CompliancePlus).

In this session, Josephine and Queenie explained the statutory and regulatory framework of Hong Kong's Anti-Money Laundering and Counter Terrorist Financing regime with reference to the Anti-Money Laundering Ordinance, Drug Trafficking (Recovery of Proceeds) Ordinance, Organised and Serious Crimes Ordinance of Hong Kong, and the United Nations (Anti-Terrorism Measures) Ordinance and Financial Action Task Force.

They then elaborated further about AML/ CTF/ control system including the use of a risk based approach when implementing due diligence and know your client procedures.

4. SFC New Professional Investors Regime and New Client Agreement requirement on suitability

This session was jointly presented by Ms. Josephine Chung (Director of CompliancePlus) and Ms. Chelsea Cheung (Compliance Analyst of CompliancePlus).

They discussed the New SFC Professional Investors Regime effective from March 2016 and explained the changes and the process for conducting suitability on individual professional investors and corporate professional investors assessment and the SFC new client agreement requirement on suitability.
